Alumni's feedback 2021-2022



2. Students suggested to include "Drafting of Pleadings and Conveyancing" subject from the First year so that students will learn better skills of drafting.
3. Students suggested to add Courses of practical importance like Cyber Laws and Information Technology so that they can solve said litigations in the future.
