IQAC members meeting was commenced at 01.30pm in which Dr. Smt. Jyoti G. Hiremath, IQAC Coordinator welcomed the members. Initially minutes of earlier meeting were read and confirmed and the agenda was taken for discussion:

Agenda 1 : To submit a report with suggestions to KSLU to revise and upgrade the syllabus for the implementation of NEP 2020

Proceedings : KSLU invited changes to be done in the existing curriculum in view of implementation NEP 2020 for Law Courses, hence it is resolved to suggest necessary changes to be introduced in respective Course syllabus or inclusion of new subject etc.

Agenda 2 : To review Feedback mechanism adopted under Criterion I

Proceedings : Already the Institution has implemented system of collecting Feedback on Curriculum from the teachers and Final year/ outgoing students every year. But now as per the requirement of Criterion I, Key indicator 1.4 : Feedback System, it is resolved that from this academic year Feedback on curriculum should also be collected from Alumni and Employer (those Advocates / LPOs with whom we have MoUs), and after analyzing all the feedbacks report should be sent to the KSLU, Hubballi



Agenda 3 : To review Internal Assessment process as under Criterion II,
Proceedings : As per the requirement of Criterion II, Key Indicator 2.5 :Evaluation Process and Reforms, to bring transparency in the Internal Evaluation system of the Institution it is resolved to display Internal Evaluation marks of each Course on the Notice Board for the knowledge of students and through Examination Committee of the College, resolve the grievances related to the same if any with a separate Register.

Agenda 4 : To adopt new method of Teachers Self Appraisal Method from this academic year as required under Criterion VI

Proceedings : The existing Performance Appraisal System of the Institution for teaching and non-teaching staff is a confidential one between the Management and the Principal but as per Criterion VI Key Indicator 6.3 : Faculty Empowerment Strategy, it is resolved to introduce new format for QnM 6.3.5: Performance Appraisal system for Teaching staff for better appraisal than the existing one from this Academic year. In this format not only the classes conducted by the faculties but also their evaluation, external duties, FDPs, paper presentation etc. will be included.

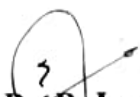
Agenda 5 : To initiate post NAAC SSR- DVV activities
